- When placed beside a MultiDesk Video Series desk, a contiguous surface is maintained.




ASSEMBLY

- 1) Install the studs in the rack top and the overbridge bottom.
- 2) Attach the rackrail (if desired) to the risers as shown using flat head screws. (Philips head screw driver required)
- 3) Install the 1/4" turn fasteners.

NOTE: The arrow points toward the stud.

- 4) Position the risers on the studs.
- 5) Position the overbridge top on the risers.
- 6) Lock all 1/4" turn fasteners.
